ORDER

APPOINTMENT OF ADVISORY GROUP  
UNDER THE CIVIL JUSTICE REFORM  
ACT OF 1990 )

Pursuant to mandate of the Civil Justice Reform Act of 1990 (Title 28, Chapter 23, United States Code), I, Paul G. Hatfield, Chief Judge of the United States District Court for the District of Montana, in consultation with the other active judges of the District of Montana, the Honorables Charles C. Lovell and Jack D. Shanstrom, hereby appoint an Advisory Group to assist the Court in the development of a Civil Litigation Expense and Delay Reduction Plan to be implemented by this court in accordance with the directive of the Act (28 U.S.C. §§ 473(a), 482(b)).

Having assessed the civil litigation profile of the District of Montana, I deem it appropriate to establish an Advisory Group consisting of ten voting members: nine members selected from the practicing bar of the District, the tenth

member being the United States Attorney for the District of Montana, or a designated representative.

Consistent with the directive of section 478(a), 28 U.S.C. § 478(a), I hereby appoint Jeremiah C. Lynch to act as Administrator\Reporter for the Advisory Group.

In order to facilitate and assist the Advisory Group in its study and development of an appropriate expense and delay reduction plan, I hereby appoint the Honorable Richard W. Anderson, United States Magistrate Judge for the District of Montana, to act as a consultant to the Advisory Group and court liaison, and Mr. Lou Aleksich, Jr., Clerk of the United States District Court for the District of Montana, to act as a consultant to the Advisory Group for the purpose of providing the group with statistical information and other resource material essential to the development of an appropriate plan.

The Advisory Group is to be advised that I shall forthwith consult with Mr. Richard Cebull, Chairman of the Advisory Group, to establish a timetable for accomplishment of the Advisory Group's duties and ultimate development of a proposed Civil Litigation Expense and Delay Reduction Plan for the District of Montana.
