MEMORANDUM TO: Senior Staff

SUBJECT: Housing for Judgeships in the Biden and Brooks Bills

We have reviewed the effect of the proposed judgeships in the combined Biden and Brooks bills on the Judiciary's housing capabilities. Attached is a housing status report -by districtwhich details how the housing requirements for the new judgeships in this year's legislation will be met.

### I. Circuit Judgeships

There are 11 additional judgeships between the two bills. Because permanent locations for these judgeships cannot be identified, it is not possible to know which positions will require construction of chambers space.

#### II. District Judgeships

There are 74 additional ((60) permanent and (14) temporary) judgeships requiring accommodations:

- A. Forty judgeships already have been planned for in a prior to 1990, 1990,1991, or 1992 prospectus project (a project with General Services Administration costs exceeding \$1.5 million and which requires Congressional authorization) or have accommodations available.
- B. Twenty-four facilities requirements do not appear in any budget request and must be budgeted;
- C. Seven judgeships facilities have been included in the 1991 budget as non-prospectus projects and would be funded subject to Congressional appropriations and Executive Committee priorities; and
- D. Three require the development of a new prospectus by the General Services Administration.

### III. Bankruptcy Judgeships

There are 12 proposed bankruptcy judgeships:

- A. Four can be accommodated through a prior to 1990, or 1990 prospectus, or already have accommodations available;
- B. Four facilities requirements do not appear in any budget request and must be budgeted;
- C. Two judgeships can be accommodated in the 1991 budget as part of a non-prospectus project (subject to Congressional appropriations and Executive Committee priorities); and
- D. Two require the development of a new prospectus by the General Services Administration.

The final location of judgeships is at the discretion of the districts and circuits. This housing status report may change, therefore, if decisions are made which change the probable locations of the proposed judgeships.
