UNITED STATES DISTRICT COURT General Rule 49

The United States District Court for the District of New Jersey has established a permanent mediation program. This mediation program is governed by General Rule 49, which appeared in the *New Jersey Law Journal* on March 1, 1993.

The intent of General Rule 49 is to employ mediation in the settlement of complex civil actions. However, the Rule also emphasizes that parties in any civil case pending in the District may agree to mediation. The District Court recommends that each member of the bar give serious thought to participating in mediation and encurages lawers to communicate their interest in mediating a particular cae to the assigned District Judge or Magistrate Judge.
