Those figures reflect that the number of cases placed in arbitration in 1992 increased by 47% over 1991. The figures also reflect a significant increase in the number of cases closed before the appointment of an arbitrator or an arbitration hearing. Although the total number of cases pending in arbitration increased in 1992 over 1991, this appears to be a reflection of the significant increase in the number of cases placed in arbitration. The remaining statistical categories demonstrate a consistency in the manner in which arbitration cases are disposed of in the District. Whether these remaining categories will show an increased disposition rate consistent with the increased number of cases placed in arbitration must
