This is the first report in the nation to be filed under the Act.

The Advisory Group is a prototype of the litigants and the practitioners in this Court, with a balance of the total range of affected interests in the complex of litigation that comes before the Court. Its members were selected, as the Chief Judge declared, because all of them are experienced in their fields and committed to the mission set out in this legislation.

We began our undertaking in early March, 1991. At the beginning we decided we could best discharge this responsibility by acting as a committee-of-the-whole meeting in plenary session. We invited each of the judges of the Court, active and senior, to share their perceptions of the present situation, the problems they found and the solutions they would recommend. We solicited, through direct mailings, comments from such diverse groups as prisoners, labor unions, city and state agencies, universities and legal organizations representing specific groups. We conducted public hearings and informal meetings among special task forces of the Advisory Group, reaching out with questionnaires and other informal surveys of the litigants and the lawyers who practice here.

We believe that this intensive effort, distilled through the collective experience that all of us have brought to this mission, represents a fair and objective consensus of the views of this Advisory Group on recommendations that should be offered to our counterparts in the nation, for a model plan to reduce expense and delay in civil litigation in the federal courts.

We invite your comments on our efforts. Please send them to me, as we continue to implement these recommendations in the development of the model plan of this metropolitan pilot court.
