ORDER

RE:

Whereas, the Jury Selection Plan now in effect in this District provides, among other things, that commencing in January, 1986, and every two years thereafter, the Master Jury Wheel and the Qualified Jury Wheel for each division shall be emptied and reconstituted; and

Whereas, the aforesaid jury wheels were reconstituted beginning in February, 1993, pursuant to an Order of this Court entered on February 17, 1993, and approved by the reviewing Panel of the Fourth Circuit on March 18, 1993; and

It is accordingly hereby Ordered that the following amendments be made to this District's Jury Selection Plan:

I. That the Master Jury Wheel and the Qualified Jury Wheel in the Southern Judicial District of West Virginia shall be refilled from the voter registration lists compiled for the 1994 General Election by July 1, 1995, and every two years thereafter.

II. That the Master Jury Wheels for the various divisions of this Court be reconstituted as follows:

1. Charleston Division - The number of registered voters as reflected by the voter registration list for each of the counties comprising the Charleston Division are set forth in Appendix A attached hereto. The total number of registered voters in the Charleston Division as of November, 1994 was 176,367, and the Court finds it desirable that approximately 8,000 names be selected from the total registered voters for this division to be placed in the Master Jury Wheel of this division. To accomplish this purpose, it is Ordered that the names of prospective jurors for the Charleston Division be selected from the voter registration list of each of the counties in this division in multiples of 22.

2. Beckley Division - The number of registered voters as reflected by the voter registration list for each of the counties comprising the Beckley Division are set forth in Appendix A attached hereto. The total number of registered voters in the Beckley Division as of November, 1994 was 96,675, and the Court finds it desirable that approximately 4,000 names be selected from the total registered voters for this division to be placed in the Master Jury Wheel of this division. To accomplish this purpose, it is Ordered that the names of prospective jurors for the Beckley Division be selected from the voter registration list of each of the counties in this division in multiples of 24.

3. Bluefield Division - The number of registered voters as reflected by the voter registration list for each of the counties comprising the Bluefield Division are set forth in Appendix A attached hereto. The total number of registered voters in the Bluefield Division as of November, 1994 was 53,441, and the Court finds it desirable that approximately 4,000 names be selected from the total registered voters for this division to be placed in the Master Jury Wheel of this division. To accomplish this purpose, it is Ordered that the names of prospective jurors for the Bluefield Division be selected from the voter registration list of each of the counties in this division in multiples of 13.

4. Huntington Division - The number of registered voters as reflected by the voter registration list for each of the counties comprising the Huntington Division are set forth in Appendix A attached hereto. The total number of registered voters in the Huntington Division as of November, 1994 was 109,389, and the Court finds it desirable that approximately 5,000 names be selected from the total registered voters for this division to be placed in the Master Jury Wheel of this division. To accomplish this purpose, it is Ordered that the names of prospective jurors for the Huntington Division be selected from the voter registration list of each of the counties in this division in multiples of 22.

5. Parkersburg Division - The number of registered voters as reflected by the voter registration list for each of the counties comprising the Parkersburg Division are set forth in Appendix A attached hereto. The total number of registered voters in the Parkersburg Division as of November, 1994 was 60,253, and the Court finds it desirable that approximately 4,000 names be selected from the total registered voters for this division to be placed in the Master Jury Wheel of this division. To accomplish this purpose, it is Ordered that the names of prospective jurors for the Parkersburg Division be selected from the voter registration list of each of the counties in this division in
