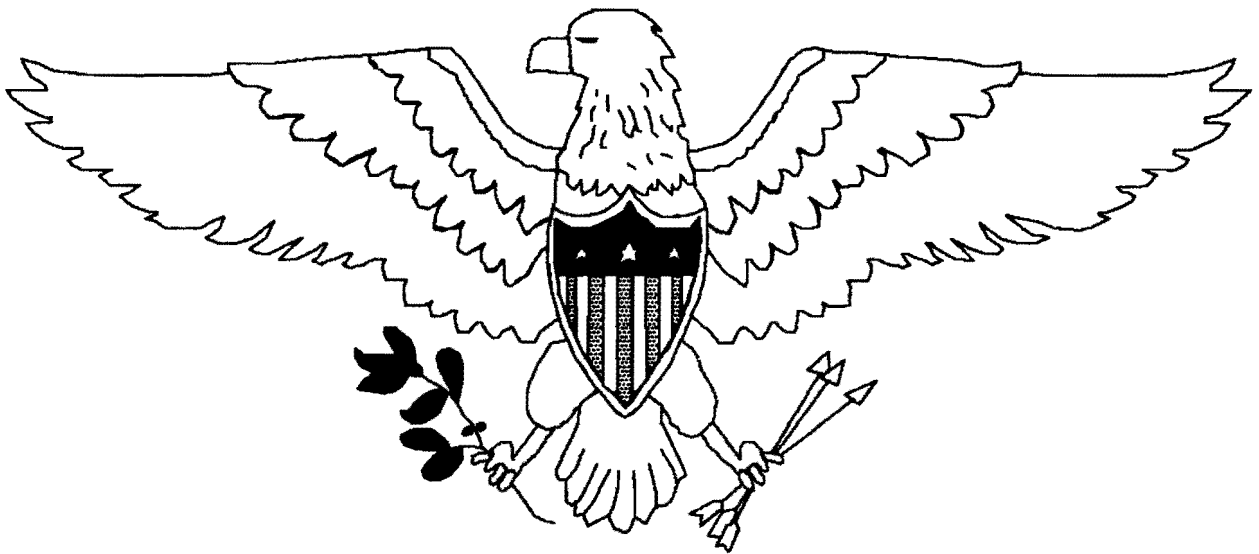

Packet Format

This packet contains all the cases that were filed and closed in the District of Nebraska between the years 1986 and 1991. The cases in this packet are first separated by the year in which they were filed. A case is counted only once so if a case runs into the following year, it is only tabulated in the filing years figures. For example, if a case is filed in 1986 and is pending for 750 days, we only count that case in our 1986 figures even though the case is not closed until 1988. Also, cases that are still pending are not counted in our tabulations. This explains why we have more cases represented in earlier than latter years.

The first page of each year gives you a totals sheet of all the cases filed within that year. This page is then broken down in the following pages by the judges who disposed of the cases for that year. At the end of each years section, we then display graphs that may make trends and inconsistencies in the District of Nebraska's court system appear more apparent.

Worksheet Format

The top left hand corner of each worksheet displays who disposed of that particular grouping of cases and the year in which those cases were filed. The columns above the cells containing the figures are the different time intervals and motions any particular case could reach or possess. These columns are further explained

in our Worksheet Columns section following this explanation. The rows going down the left hand side of the cells separate the cases by their nature of suit. You simply go down the columns and across the rows to find tabulations for the column and row you want. For example, the first nature of suit on every worksheet is Contract. The first category of the columns is Judgment. If you want to match Contract with Judgment, you just go down the Judgment column and right from the Contract row to where the two points meet. The first number within that cell represents the average number of days for the interval or motion pending. The second number symbolizes the number of cases that fit that particular category.

Worksheet Columns

Judgment: The judgment column shows the number of days from filing to disposition.

Dismissal: The dismissal column shows the number of days that a motion to dismiss was pending. If more than one motion was filed, the number of days counted were from the date that the first motion was filed to the date of the ruling on the last motion filed. The only dismissal motions which were counted were those motions to dismiss which, if granted, would be dispositive of the case, rather than those which would have been dispositive as to one defendant only.

Continuances: The continuance columns show the total number of days that a case was pending on a continuance. Three types of continuances were counted:

A) Motion for extension of discovery:

This column reflects the number of days from the filing of the motion to the date that the discovery was extended.

B) Motion for extension of trial:

This column reflects the number of days between the filing of a motion for extension of trial to the date to which the trial was continued.

C) Motion for extension of time to submit a brief:

This column reflects the number of days between the date of filing of a motion for extension of time to submit a brief to the date the brief was due.

Total

Continuances: This column reflects the total number of days that a case was continued.

Stays: This column reflects the total number of days that an ordered stay was in effect.

Page 2 Worksheet Columns

Discovery: This column reflects the number of days between the filing of the last answer and the conclusion of the discovery date as set forth in the progression order.

Summary Judgment: This column reflects the number of days from the filing of a summary judgment motion to the ruling on same. If more than one motion for summary judgment was filed, the number of days counted were the days from the filing of the first motion to the ruling on the last motion.

Pretrial/Trial: This column reflects the number of days between the final pretrial conference and the first day of trial.

Pretrial/Judgment: This column reflects the amount of days between the final pretrial conference to the date of judgment.

Trial/Filing: This column reflects the amount of days between the filing of the case and the first day of trial.

Submissions: This column reflects the number of days between the last day of trial to the date of the filing of memorandum opinion and order. This column applies only to non-jury cases.

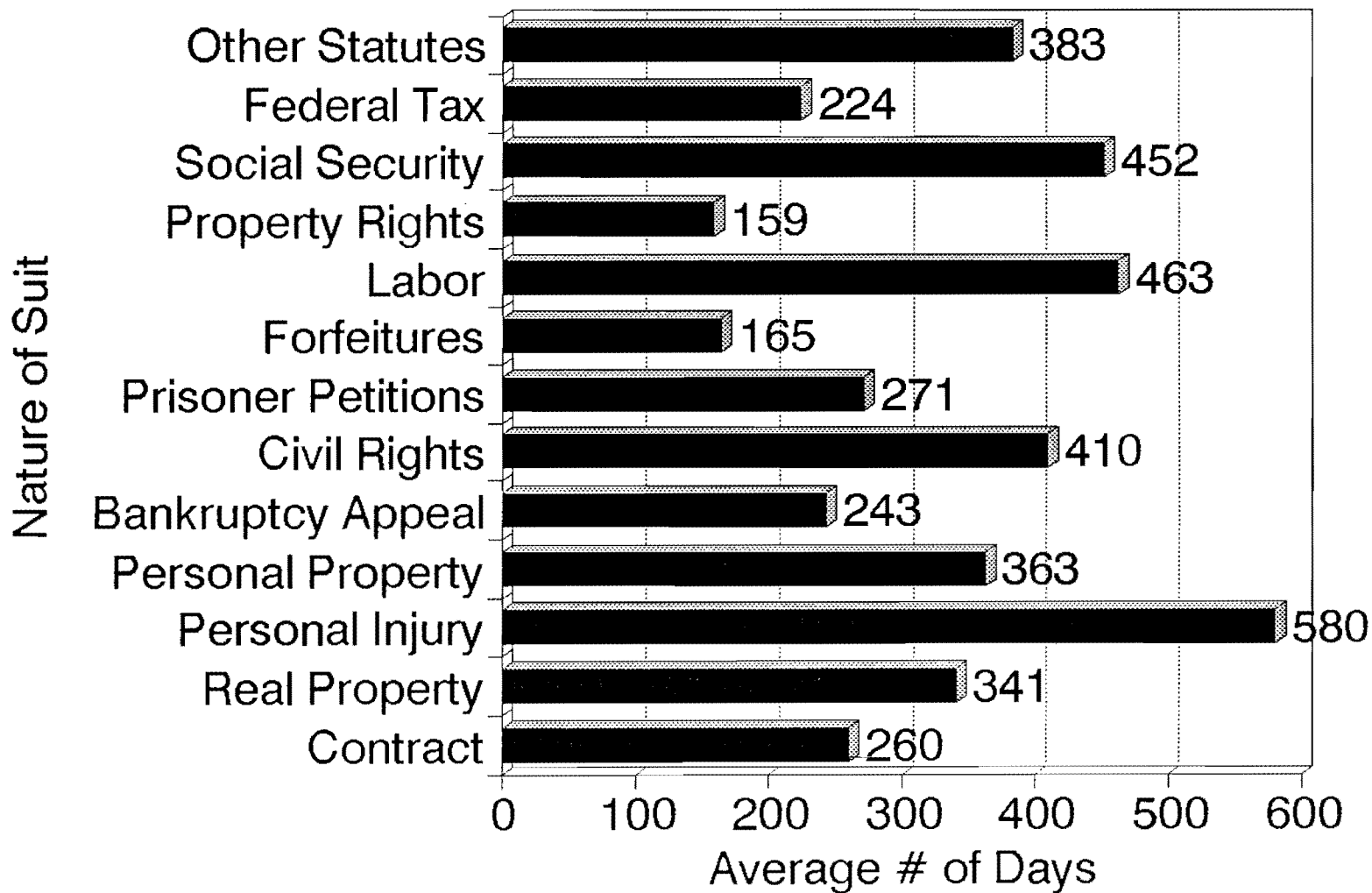

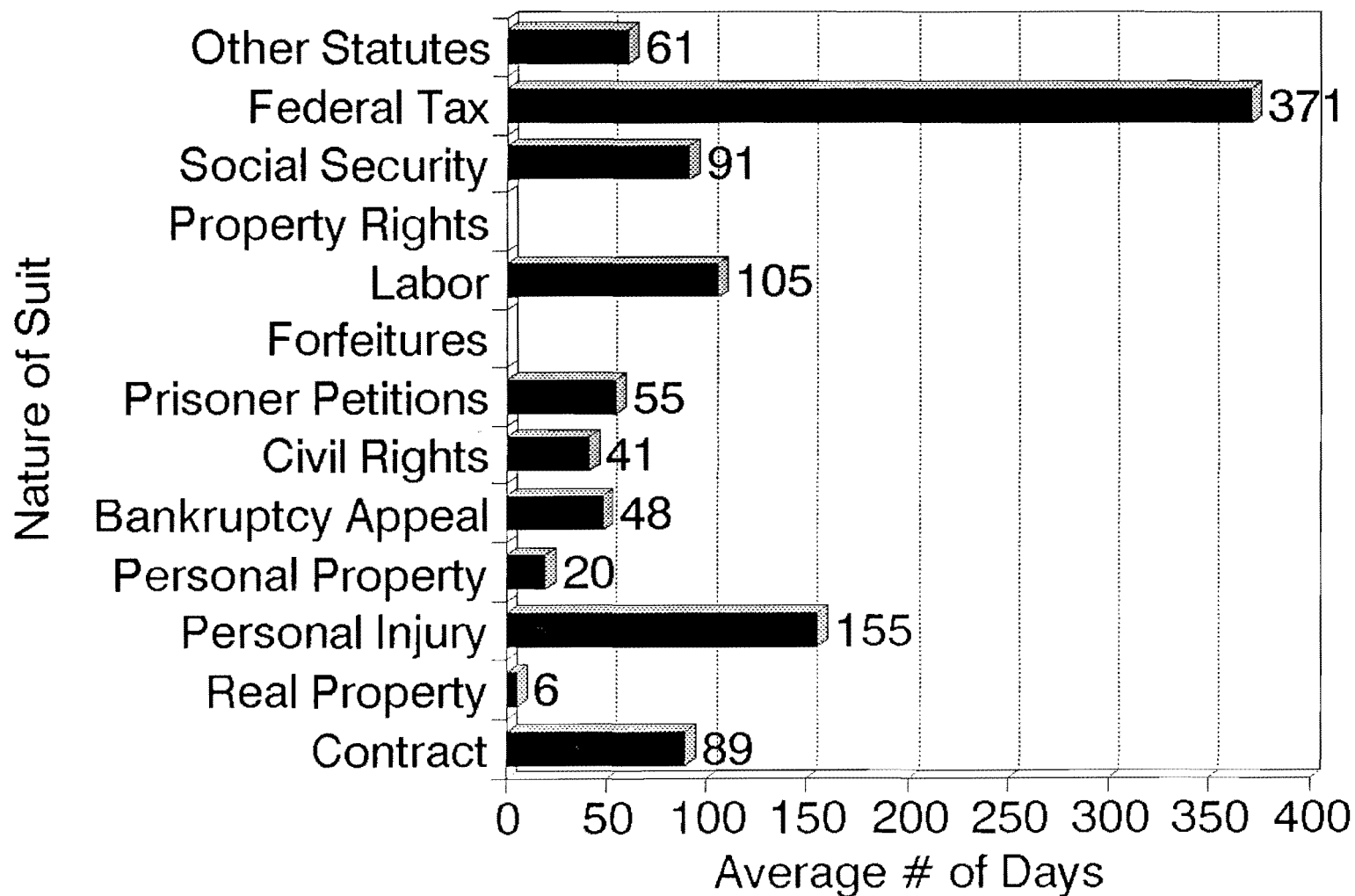

Length of Continuances



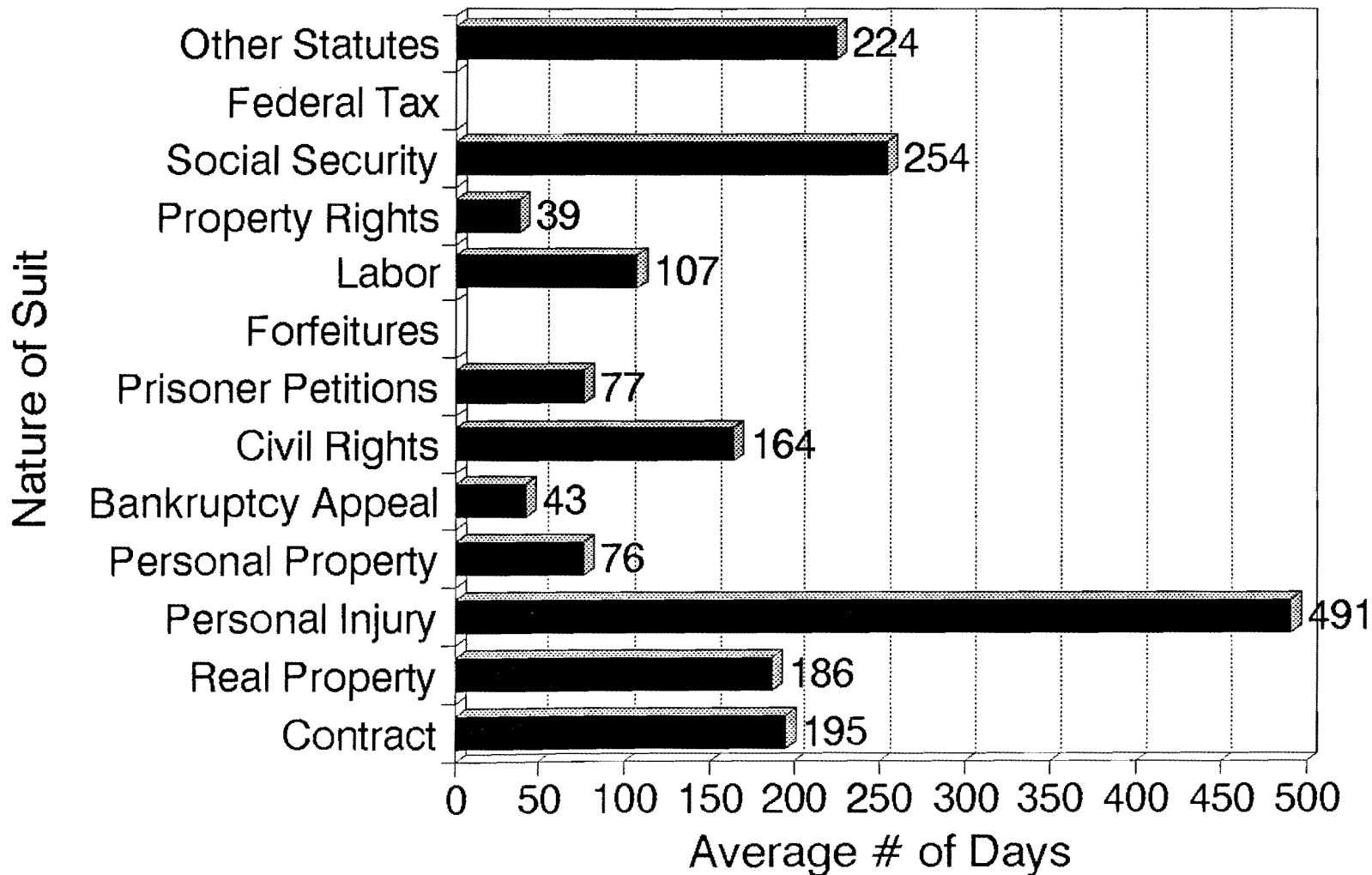

Discovery Period



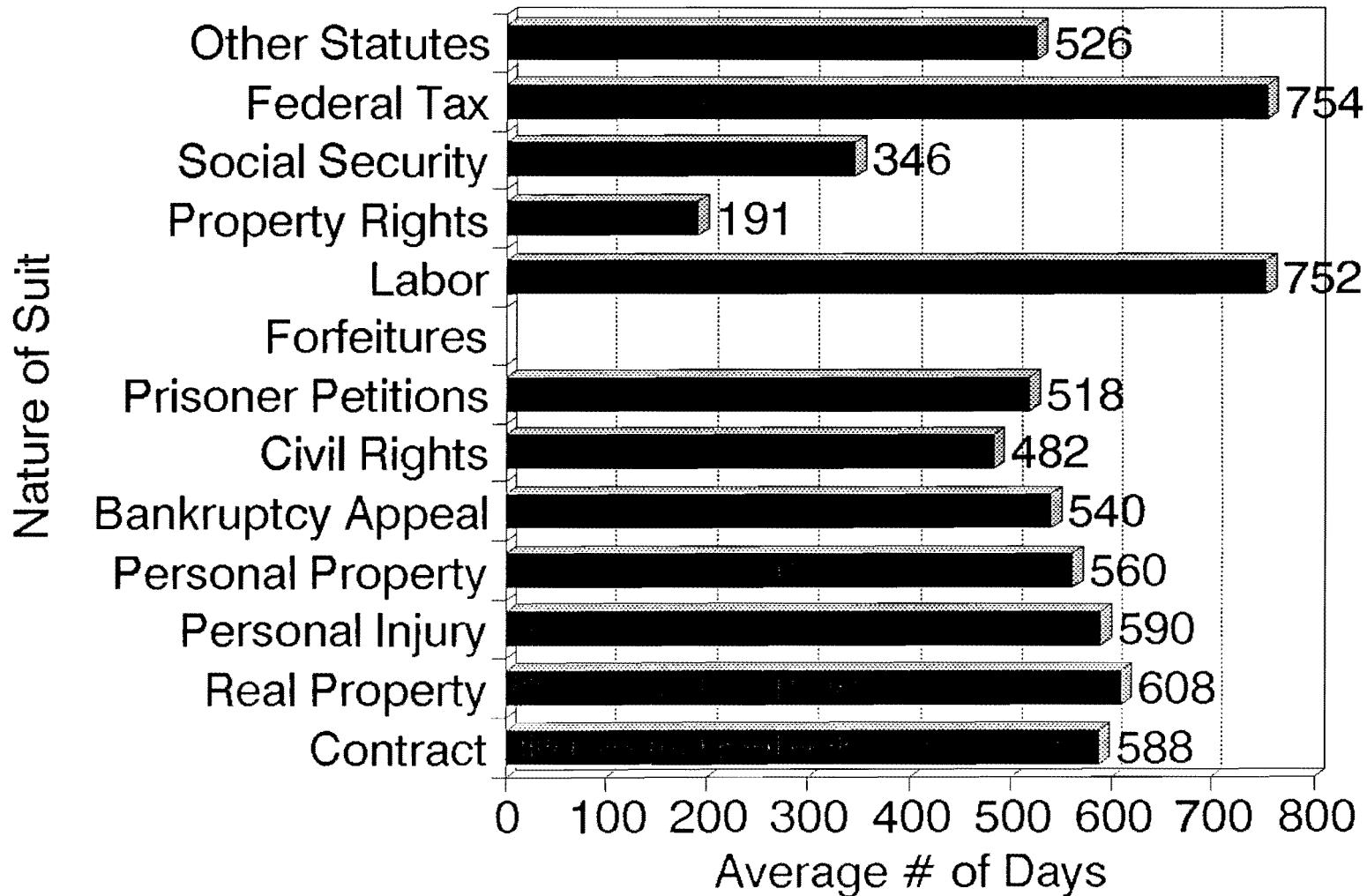

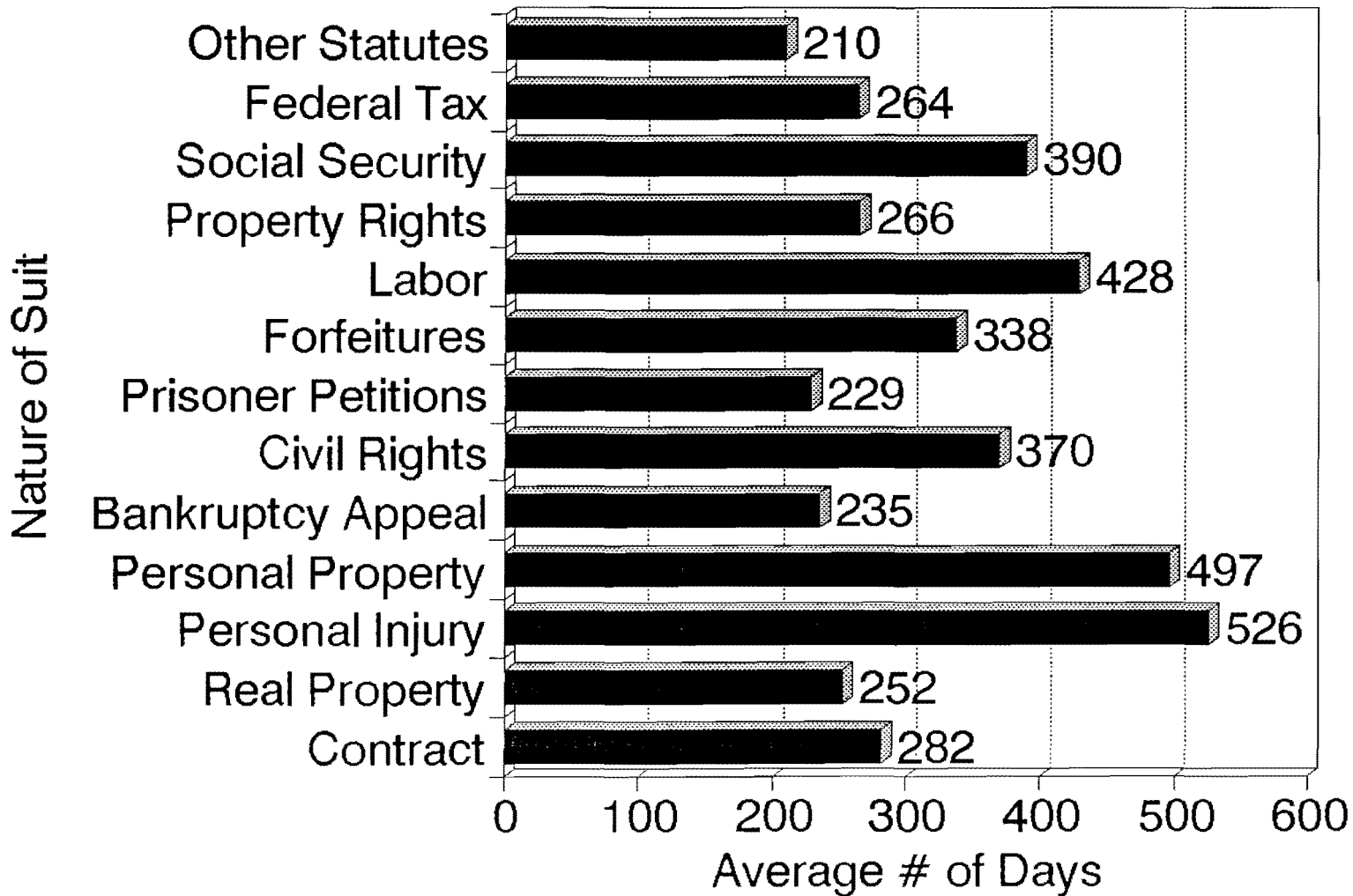

Discovery Period



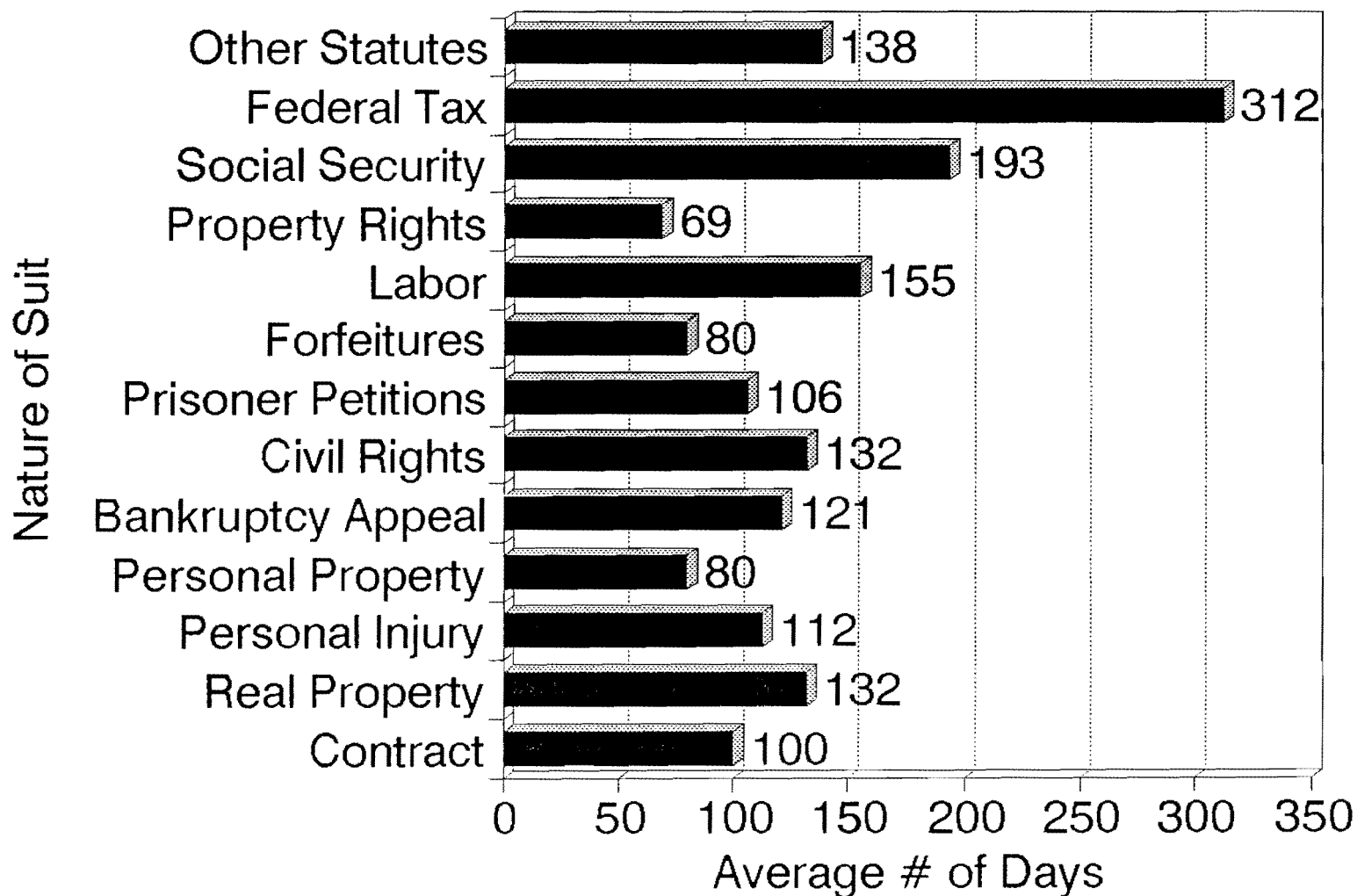

Length of Continuances



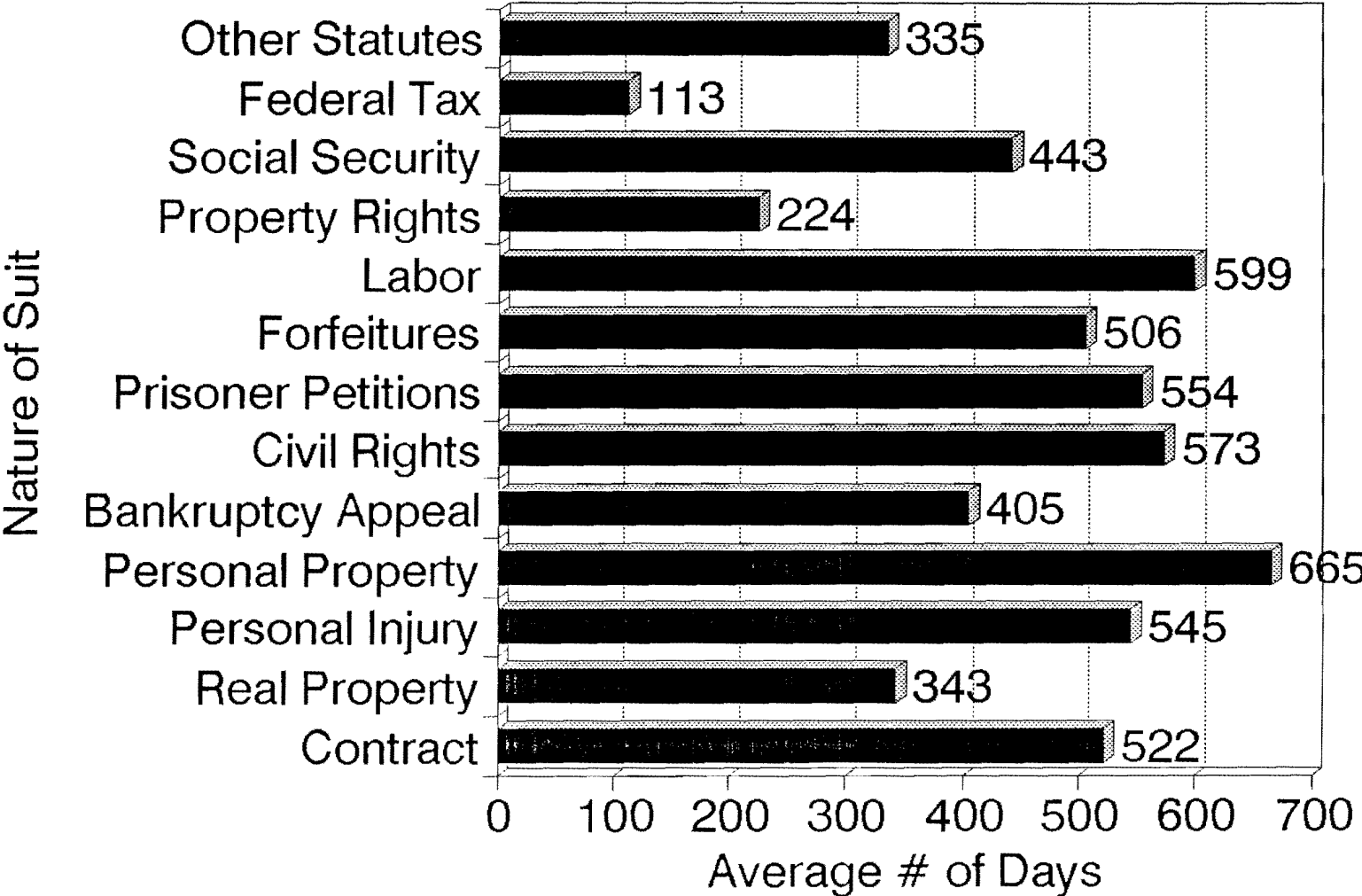

Summary Judgment Pending



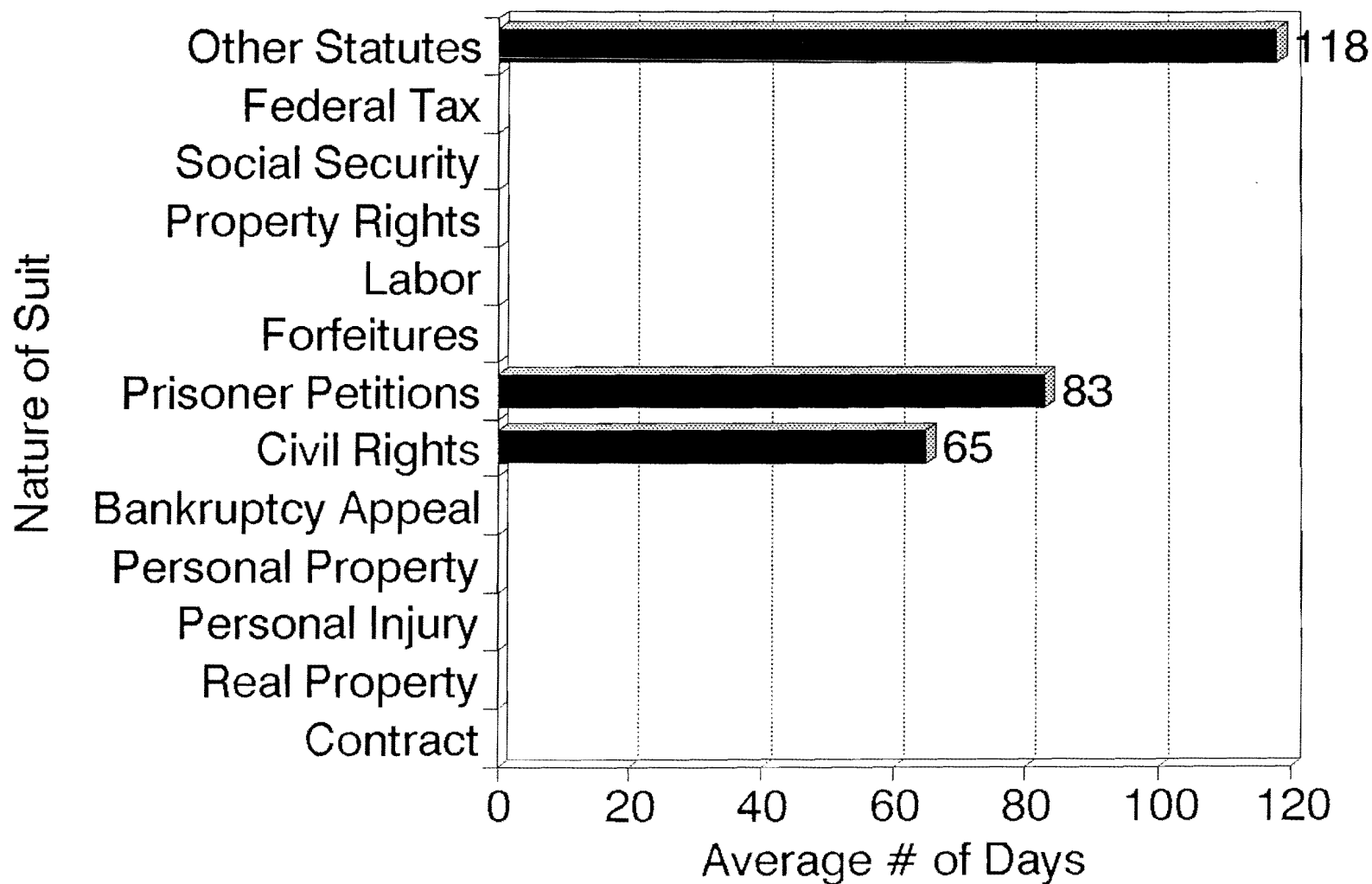
