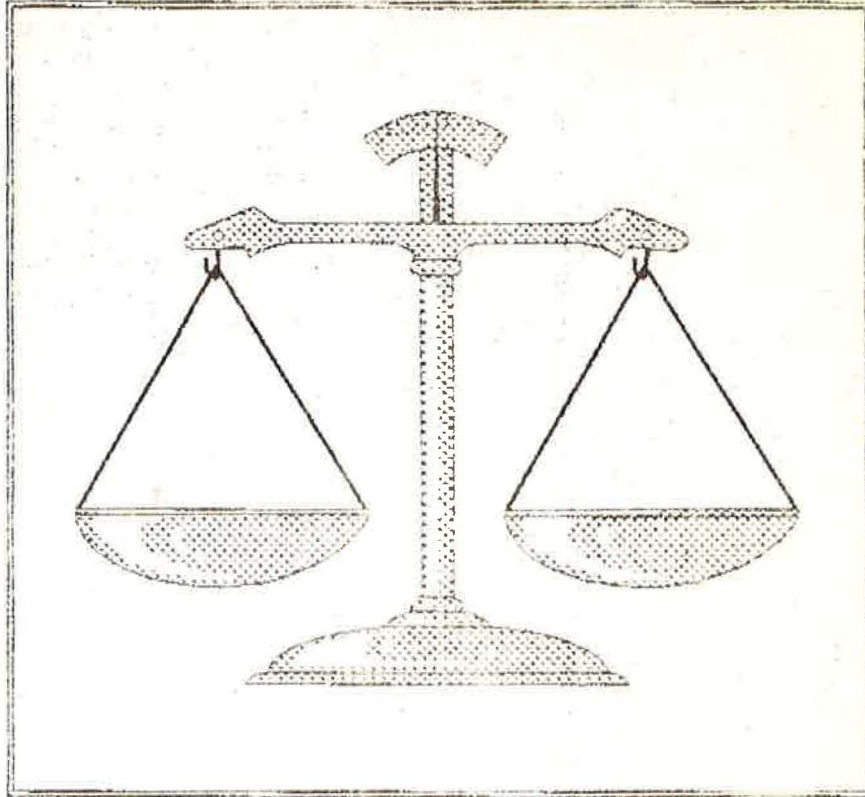


1. James P. Connelly, attorney at law, Spokane, Washington, as a representative of the American College of Trial Lawyers.
