MEMORANDUM TO MR. L. RALPH MECHAM, DIRECTOR

SUBJECT: CJRA REPORTS

In our last conversation on the status of CJRA reports of motions and bench trials, I mentioned that we would keep you posted on our progress and on the list of judges who did not report. We have now received all reports from the circuit executives (the Third arrived yesterday). There were 10 individual district judges and 12 magistrate judges who did not report.
