NOTICE OF COMMENCEMENT OF CHAPTER 9 CASE

COMMENCEMENT OF CASE: On January 6, 2014, Ozark Mountain Solid Waste District petitioned for relief under Chapter 9 of the United States Bankruptcy Code, in the Western District of Arkansas, Harrison Division. All documents filed with the Court are available for inspection at the office of the Clerk of the United States Bankruptcy Court for the Western District of Arkansas, 35 E. Mountain Street, Rm 316, Fayetteville, AR 72701. Telephone (479) 587-9800.

AUTOMATIC STAY: The filing of the Debtor's Chapter 9 petition commences an Automatic Stay, applicable to all entities, of all actions against the Debtor or its property, including but not limited to: the enforcement of any judgment, any act to obtain property from the Debtor; any act to collect assets, or recover a claim against the Debtor or its property; and the commencement or continuation of any judicial, administrative or other action or proceeding against the Debtor, that was or could have been commenced before the Debtor filed its Chapter 9 case. 11 U.S.C. §362, 11 U.S.C. §922. Note: Pursuant to Order of this Court entered January 28, 2014, the Automatic Stay does not apply to the Arkansas Department of Environmental Quality.

PROOF OF CLAIM: The Debtor has filed a list of creditors pursuant to requirements of 11 U.S.C. §924. Under 11 U.S.C. §501 a Proof of Claim is deemed filed for any listed claim unless it is identified as disputed, contingent, or unliquidated as to amount. At this time no claim is listed as disputed, contingent or unliquidated as to amount. If that changes, the Court may establish a deadline by which Proofs of Claim must be filed. Should that happen, a notice of such deadline and

the procedure to be followed will be served upon creditors as directed by the Court.

CHAPTER 9 PLAN: The Debtor has sought Bankruptcy Court protection so that it may continue to function and operate while it prepares a plan of adjustment of creditor claims, and liquidate its assets pursuant to the requirements of the U.S. Bankruptcy Code. Creditors will be given notice concerning any plan and/or liquidation.

RIGHT TO OBJECT AND HEARING: Any creditor has the right to object to the filing of the Debtor's Chapter 9 petition, and to request dismissal of the case. Any such objection should be filed in writing within thirty (30) days of the date stated below. Objections shall be addressed to the Clerk, United States Bankruptcy Court, 35 E Mountain Street, Room 316, Fayetteville, AR 72701. A copy of any objection must also be sent to the attorney listed below.
