

The Dolley Madison House

One of Washington's most historic buildings, this house was build in 1818 and purchased by President Madison in 1828. Following the death of the President in 1836 Mrs. Madison moved from their Virginia home to return to this house and the Washington life she so much loved. She died here in 1849. From 1851-1881 this was the home of Rear Adm. Charles Wilkes, USN and his family. In more recent years it was occupied by the Cosmos Club, and in 1940 was purchased by the United States Government. Refurbishing was completed in the fall of 1968, and it was formally dedicated as the headquarters of the Federal Judicial Center November 1, 1968, by Chief Justice Earl Warren.
