This program uses an extensive selection of historic images and documents to tell the story that culminated with the Supreme Court's decision about the freedom of the Africans from the Amistad.

How do they do it?

The bankruptcy court for the Western District of Pennsylvania uses videoconferencing for many hearings. While this technology isn't new, and the Western District isn't the only court using it, the district has learned valuable lessons from its use of this technology, and applies them vigorously.
